Event Agreement Form

- I. **Deposit:** A fifty (\$50) dollar deposit is required to secure pony/horses. Animals shall not be considered reserved until the deposit is received. Event agreement must be signed. The remaining balance is due upon our arrival to the event site. If agreement is not honored, and legal actions are required, any attorney fees and other costs to enforce this agreement are the responsibilities of the Responsible Adult. Deposits are non-refundable. If inclement weather, at the discretion of the Xtreme Team, deposit may be applied to a reschedule date based on Xtreme Team availability. _____ **Initials**
- II. **Refund Policy: Postponement.** If inclement weather, rain or high winds are forecasted for the time that your event is scheduled, then client has the right to postpone the event. Xtreme Team Stables must be notified of the postponement before traveling to the event. Client may reschedule the event within 30 days of the original event date at no additional cost. If postponement of an event is necessary, Xtreme Team Stables reserves the right to substitutions of equal or lesser value on the rescheduled event date. If postponement of the event is made after travel to the event has begun, Deposit may not be used to reschedule and up to 75% of contract price may be charged to cover travel expense. Once the pony/horse has arrived, 100% may be charged and postponement of the event is not available. When rain is forecasted for the time that the event is scheduled a representative from Xtreme Team Stables may contact the client. If the Xtreme Team Stables representative recommends that the event be postponed, rescheduled or cancelled, but client insists that the pony/horse set-up anyway, and the event thereafter is rained upon during the event, there is no refund or rescheduling. An event/party may be cancelled without loss in money, except deposit, if a 48 hour advanced notice of scheduled event is given to an Xtreme Team Stables representative. _____ **Initials**
- III. **Cancellation:** If a reservation is cancelled after travel to the event has begun, the deposit is non-refundable or negotiable to use for rescheduling. If the event is cancelled after Xtreme Team Stables has arrived on site of the event, the full booking charge is payable. An event may be cancelled without loss in money, except deposit, if a 48 hour advance verbal notice of scheduled event is given to an Xtreme Team Stables representative. _____ **Initials**
- IV. ***Overtime:** Event times are reserved for 1-1 1/2 hours. If time allows or no other events are booked at requested time, \$75 is charged for each additional 1/2 hour and payment must be received in cash or a credit card payment before extending our services.* _____ **Initials**
- V. **Damages:** Acts of God may prevent us from attending the contracted event. Should the event be affected, Xtreme Team Stables reserves the right to reserve another date and time. Ponies/Horses may disturb grass/lawns. Horses/ponies may drop manure. Xtreme Team will remove most of this by the end of the party. Lawn areas, hedges, or trees that you do not want the ponies/horses near, notify Xtreme Team Stables representative at the beginning of the party, before setup. _____ **Initials**
