

Trail Ride Agreement and Liability Release Form

Important Alert & Risk Notification:

SERIOUS INJURY MAY RESULT FROM YOUR PARTICIPATION IN HORSEBACK AND/OR TRAIL RIDING. XTREME TEAM AND/OR ANY INDIVIDUAL/INSTRUCTOR AFFILIATED AND/OR CONNECTED WITH XTREME TEAM DOES NOT GUARANTEE YOUR SAFETY OR THAT OF ANY HORSE. THE RIDER AND/OR GUARDIAN AGREE TO RIDE AT THEIR RISK.

In consideration for participating in horse-related activities; including but not limited to trail riding, being near horses or ponies the undersigned hereby agrees as follows:

1. REGISTRATION OF RIDER AND PURPOSE OF AGREEMENT: I, the following listed individual hereinafter known as the "RIDER" and the parents or legal guardian thereof if a minor, do hereby voluntarily request and agree to participate in horse riding or trail riding. Rider will ride a horse provided to him or her by Xtreme Team, his or her own horse, or one borrowed or leased by Rider's own arrangement.

2. SCOPE OF AGREEMENT AND DEFINITIONS: This agreement shall be legally binding upon me, the RIDER, and the parents or guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and parental representatives. This agreement shall be interpreted according to the laws of the North Carolina. If any clause, phrase or word is in conflict with the laws of the State of North Carolina- that single part is null and void. The term "HORSE" herein shall refer to all equine species. The term "Riding" or "Horseback Riding" herein shall refer to riding, instruction in, or otherwise handling of or being near horses or ponies, whether from the ground or mounted. The term "RIDER" shall herein refer to a person who rides a horse or otherwise handles or comes near a horse from the ground. The terms "I", "me", and "my" shall herein refer to the above RIDER and the parents or legal guardians thereof if a minor.

3. INHERENT RISK OF ACTIVITY: I understand that horseback riding is a rugged recreational activity and that there are numerous obvious and non-obvious inherent risks always present in such activities despite all safety precautions. As such, related injuries can be severe or even deadly and, at the least, can require hospital stay and result in lasting residual effects than injuries from most other activities. Further, this inherent risk is not totally mitigated by either (1) the presence of an instructor or trainer or (2) by the use of a horse that has been used for or is considered usable for the instruction of beginners. Horse accidents are common and, in fact, are virtually guaranteed to occur given enough time around horses. Horse accidents are even more common with beginners although expert riders are still subject to considerable (sometimes fatal) danger from participation in this activity. I acknowledge the risk and potential risks of pony or horse activities and interaction irrespective of training, or temperament; including risk of bodily injury, or death resulting from kicks, bites, falling off pony or horse, pony or horse falling on rider, being dragged by foot caught in stirrups, being thrown by the pony or horse, equipment failure or collision with pony or horses or vehicles or other inanimate objects, jumping, bucking, I hereby intending to be legally bound for myself, my heirs and assigns, executors or administrators, waive and release forever all claims for damages against Xtreme Team, its employees and all other entities for any and all injuries and/or losses I may sustain as a result of use of Xtreme Team equipment or facilities.

4. NATURE OF RIDING HORSES: I understand that Xtreme Team will perform every effort to provide calm and safe horses according to their standards, yet, no horse is a completely safe and calm horse. If a horse is frightened or irritated it may divert from any training it has received and act according to its natural survival instincts, "flight or fight" which may include but are not limited to: stopping short, changing directions or speed at will, shifting its weight, kicking, biting, running under obstacles, or running from danger.

5. RIDER RESPONSIBILITY: I understand that upon taking control of the reins- I accept and have control of the horse. The RIDER'S safety largely depends upon his or her ability to carry out simple instructions, and his or her ability to remain balanced aboard the moving animal (which is not easy for beginners). The RIDER shall be responsible for his or her own safety and that of an unborn child if the rider is pregnant. Pregnant women should ride horses only under the advice of their physician. Xtreme Team strongly advises pregnant women not to ride horses.

6. CONDITIONS OF NATURE: Xtreme Team is not responsible for any acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or otherwise react in some unsafe way. **Examples Include:** insects or reptiles which may walk, run, fly near, bite and/or sting a horse or person, wild and domestic

animals, wind, lightning, thunder or rain. Further, Xtreme Team is not responsible for irregular or obstructed footing on groomed or wild land (including indoor or outdoor arenas, pens, or pastures), which is subject to constant change in condition according to use, weather, temperature, maintenance (or lack thereof) and natural and man-made changes in landscape. Further still, Xtreme Team is not responsible for activities engaged in by others such as, but not limited to, hunters, gun sounds, car drivers or occupants honking horns or throwing objects to scare a horse.

7. ACCIDENTAL AND PERSONAL LIABILITY INSURANCE: I agree that should medical treatment be required, I and/or my own accidental/medical insurance company shall pay for all such incurred expenses and deductibles. Should my actions or that of my horse cause injury or damage of any kind, I and/or my own personal liability insurance company shall pay for such damages. I agree not to hold Xtreme Team responsible for any medical related expenses or injuries.

8. PROTECTIVE HEADGEAR WARNING: I agree that for myself and on behalf of my child and/or legal ward I have been fully warned and advised by Xtreme Team that an ASTM/SEI approved helmet should be worn while riding and being near horses and I do understand that the wearing of such headgear at these times may reduce the severity of some of the wearer's head injuries and possibly prevent the wearer's death from happening as the result of a fall and other occurrences.

9. LIABILITY RELEASE: I agree that in consideration of Xtreme Team allowing my participation in this activity under the terms set forth herein, I, the RIDER, for myself and on behalf of my child and/or legal ward or other parent, heirs, administrators, personal representatives or assigns, do agree to hold harmless, release, and discharge Xtreme Team, its owners, agents, independent contractors, employees, officers, directors, representatives, assigns, members, owners of premises and trails (whether or not such premises or trails are owned by Xtreme Team, affiliated organizations and insurers and others acting on its behalf (hereinafter, collectively referred to as "Associates") of and from all claims, demands, causes of action and legal liability, whether your damage be known or unknown, anticipated or unanticipated due to Xtreme Team and/or its Associate's ordinary negligence; and I do further agree I shall not bring any claims, demands, legal actions and causes of action, against Xtreme Team and its Associates as stated above in this clause, for any economic and non-economic losses due to bodily injury, death, property damage, sustained by me and/or my minor child or legal ward in relation to the premises and operations of Xtreme Team, to include while riding, handling, or otherwise being near horses owned by or in the care custody and control of Xtreme Team, whether on or off the premises of Xtreme Team.

10. ATTORNEY'S FEES: I agree that in consideration of Xtreme Team allowing my participation in this activity under the terms set forth herein agrees to indemnify Xtreme Team and its Associates for all reasonable attorneys fees and related costs incurred in defending themselves against any compensatory actions taken or threatened by the Rider, the parents or guardians thereof, or his or her heirs, estate, assigns, including all minor children, and parental representatives. As much as we enjoy making our horses available to various riders (paying or otherwise), we respectfully request that if Rider believes that a horse-related personal injury or death is justifiable grounds for shifting any part of the financial, emotional, and physical burdens of his or her injury back to Xtreme Team or its Associates, then please do not participate in this activity with our horses. Thank you.
